### I Funding Agencies and types of Funding:

- \* County Human Services Departments (Stearn's, Benton, Sherburne and Todd)
- \* DHS State of Minnesota Dept. of Human Services (DHS)
  - \* RSB Rehabilitation Services Branch of the Dept. of Employment & Economic Development (DEED) We also call this DRS sometimes. DRS is the old name.
- \* Private Business
  - \* CCSA: This stands for "Children & Community Services Act". This money is considered County money and usually funds those clients that live at home with a parent or relative.
  - \* Title XIX this is Medicaid funding. This funding has many rules attached to it and is quite medical in nature.
  - \* MA Waiver or Waiver this is Medicaid funding with some of the medically oriented rules "waived" so that it will cost less than Title XIX.
  - \* CADI Waiver This is a special waiver called "Community Alternatives for Disabled Individuals"
- \* TBI Waiver This is a special waiver for the "Traumatic Brain Injured"
  - \* Supported Employment Waiver A special waiver to promote supported employment for persons with disabilities.
  - \* CDCS Consumer Directed Community Supports is a method of funding services through the MA Waiver that provides families with a budget that they can direct and utilizes an agency to provide the administration of the funds.
  - \* EE Stands for Extended Employment. This is the primary funding for the Long term Employment that we provide for workers in our sheltered workshop. This is money from a program funded by the State Legislature and administered by RSB.
  - \* VR or Case Service Dollars This money is Federal money from the Federal Office of Rehabilitation Services and is administered by the Minnesota Department of Employment & Economic Development (DEED) Rehabilitation Services Branch. (RSB)
  - \* DWRS This stands for Disability Waiver Rate Setting. Historically (before 2015), WACOSA and programs providing similar services were paid per client based upon a full day, partial day and transportation. After 2016, WACOSA is now reimbursed for each client we serve based upon an individualized rate generated for each client, based upon their assessed needs.
  - \* WIOA This stands for Workforce Innovation and Opportunity Act. This was signed in to law in 2014 and was put fully implemented on July 22, 2016. This prevents school districts from contracting with any provider like WACOSA that holds a special minimum wage certificate, allowing less than the minimum wage to be paid to an individual. This act also requires new school graduates to receive career counseling before being permitted to work for less than the minimum wage, as well as, offering adults over 25 years of age currently being paid less than minimum wage to take part in career counseling at least annually.

\* Section 14(c) of the Fair Labor and Standards Act (FLSA) – allows programs like WACOSA to pay less than the state or federal minimum wage, provided time studies and performance measurements are kept current that compare the productivity of individuals with disabilities to individuals who are not disabled for the work being performed and then compared to the prevailing wage for like work being performed in standard industry. This is referred to as paying a "commensurate wage" and is subject to audit.
